MEMBERSHIP APPLICATION

Full membership _____ Associate membership _____

Full Membership may be granted only to an individual dealer and does not extend to business partners, shops or malls. Individual business partners may apply for additional full memberships or Associate Memberships. Annual dues for full membership is \$85. per calendar year.

Full membership may be held by an antiques dealer who meets the following criteria: Applicant must:

- A. Be actively involved in the sale of antiques.
- B. Have a Minnesota Sales and Use tax number and any required licenses or permits.
- C. Provide three dealer references, two of whom are current MADA members.
- D. Abide by the Minnesota Antiques Dealers Code of Ethics.

Associate membership is intended for two categories:

- A. Individuals involved in businesses or industry related to antiques, or
- B. Individuals not currently active in the sale of antiques.

Associate membership grants all the privileges of full membership with the exception of voting rights. Associate memberships must meet criteria and C above. Annual dues for Associate Membership is \$75. for one calendar year.

Code of Ethics:

In all their dealing, members of the Minnesota Antiques Dealers Association, Inc. shall adhere to moral and ethical standards of conduct so as to command respect and confidence.

You, your associates or employees will not knowingly misrepresent any item held for sale, including knowledge of its condition, age, or authenticity.

Members agree to make available a written memorandum on which will appear the selling price and a detailed description of the article sold.

Members will strive to increase their personal knowledge of antiques and encourage educational activities on behalf of the collecting public.

Each member agrees to price all items in dollars and cents
